NARRATIVE

ORIGIN:

On June 20, 2022 Eastpointe Police Department (EPPD) requested assistance with an assault investigation that occurred in their city on June 18, 2022.

INFORMATION:

According to the initial report taken by EPPD, (Mayor of Eastpointe), alleged that she was assaulted by (Eastpointe City Councilman) while at the opening ceremonies for the annual Gratiot Cruise. The ceremony was being held in the parking lot of the Eastpointe High School. During the ceremony, gave a speech to the patrons against wishes. became upset by this and confronted in an aggressive manor, causing her to feel immediate fear, panic and intimidation.

FOLLOW UP:

INTERVIEW WITH

I spoke with over the phone. She explained to me that on June 18, 2022 during the ceremony for the became upset after she made a speech to the patrons. Gratiot Cruise, was yelling at her within close distance while aggressively putting his hands in her face. continued, stating that she felt immediate fear, panic and intimidation. She asked him to go away, but he became more aggressive, causing her to feel that a physical assault was imminent. Bishop was in the immediate vicinity and screamed to him for help. As was trying to calm the situation down, continued to walk toward . She ran up the stairs and hollered to Eastpointe Police Chaplains, Pastor and Pastor , Pastor for additional assistance. The three pastor's aided in successfully calming the situation down. advised that she would like to pursue charges for assault against

INTERVIEW WITH

I made phone contact with and asked him what had transpired between at the Gratiot Cruise ceremony on June 18, 2022. informed me that during the ceremony, made a speech to the patrons against wishes. became angered by this, slamming his clip board that he was holding, down to the ground. added that he and the other pastor's prayed with both to calm the situation down. When asked if he observed an altercation between , told me that he did not.

INTERVIEW WITH

I made phone contact with and asked him what had transpired between at the Gratiot Cruise ceremony on June 18, 2022. explained to me that is the MC of the prayer service program. At some point during the ceremony, walked up on stage and asked if she could speak. told him, "No," adding that it was loud enough that everyone asked if she could speak at which time . Shortly after, stepped to the microphone and made a five minute could hear it, including slammed down his clip board and walked away visibly upset. Bishop went to talk to attempt to calm him down and followed. overheard "talking loudly" to each other. The altercation never was to the point where he felt that the two needed to be separated. They were close to each other but never face to face. also mentioned that he showed up after the altercation started so it is possible that the dispute had subsided by the time he arrived.

INTERVIEW WITH

Once I determined that was my lone eye witness to the events that transpired at the Gratiot Cruise prayer service, I made phone contact with to schedule an in-person interview. A short time later, I received a call from , who requested that just submit a written/typed statement describing the attorney, on June 18, 2022. I received the typed statement from altercation that took place between assistant on July 7, 2022. The following is a summary of the statement made by Attorney was in appeared to be in charge of the opening ceremony for the Gratiot Dream Cruise in Eastpointe on June 18, 2022. asked to give the Mayor space for remarks during the event, to said "NO," in a very loud tone. When finished with the program, which (Mayor) walked up to the microphone and addressed the audience. This enraged prompting him to slam his clipboard to the ground. As quickly walk up to her and put his finger exited the stage, observed into her face. looked at and asked for help. NARRATIVE (continuation)

I made phone contact with to schedule an in-person interview. Per my request, arrived at the Macomb County Sheriff's Office on June 29, 2022. I escorted him to the interview room at which time I informed him that he was not under arrest and was free to leave or stop answering my questions at any time. The interview was recorded in its entirety.
To summarize, explained to me that he used to be the mayor of Eastpointe and is now currently a city councilman for Eastpointe. is in charge of the Gratiot Cruise prayer service that takes place each year in the Eastpointe High School parking lot. June 18, 2022 was the date of this year's event. When he was up on stage, he looked out into the crowd to recognize the city officials that were in attendance at which time he noticed that Mayor was not in the crowd and that she was up on stage (uninvited). Multiple pastor's came to him during the service and stated that Mayor wanted to talk (to the audience). told them no, adding that this was not a city event, absolutely not. After closing out the ceremony, was leaving the stage when he heard Mayor speaking to the crowd. This upset and when she finished he confronted. He said to her, "How dare you. This is not a city function. You weren't invited to come to speak and how dare you." During the confrontation, said that was smiling. Afterward, said that he needed a prayer, at which time all five pastor's surrounded him and they prayed. When questioned further, explained that he was within a couple of yards from her during the confrontation. confirmed that he never physically touched. At this point I ended the interview.
DISPOSITION:
The facts of this case have been documented and forwarded to the Macomb County Prosecutor's Office for review.
